### Equity Membership Information

Equity Golf Certificates are required for Unlimited and Limited golf categories for a one-time investment of \$5,000 plus an annual Capital Contribution Fund fee (currently \$1,000). This includes full voting rights. With club approval, certificate benefits may be transferred from a current family to a lessee during the term of the lease. Equity members also enjoy preferred benefits, including member-only discounts on instruction and golf merchandise, advance tee time access, participation in club tournaments and events, reduced guest fees, and charging privileges in the Pro Shop. The Capital Contribution Fund fee is waived during the initial Equity Year.

## Important Pricing & Billing Details

- All rates are subject to 7% Florida sales tax.
- Monthly billing is available for Unlimited and Limited Golf Memberships upon request before November 1.
- Monthly payments may be arranged by ACH (direct bank transfer) or credit card.
- Credit card payments are subject to a 3% processing fee.
- Equity Owners are offered special discounts off membership fees, including Super Senior 100 with a 25% discount and Executive 50 and under with a 20% discount. Please ask for details.
